There is a \$25 fee for any returned check or insufficient funds, in addition to any necessary late fee. Tuition payments is due on a 30-day net. If the 30th falls on a weekend, payment will be processed on the last business day.\*

I understand that Step Up funds on a quarterly basis according to their handbook.

Payment options for scholarship funded accounts may be paid by the responsible payor on a 10- or 12-month budget. The 12-month payment plan must begin in June in advance of the school year start date. The agreement payments must be made in advance of services. Payment options are only for regular or after-school tuition, not for miscellaneous charges or other related school fees. I understand that if I default in the payment plan, the school can cancel the payment plan, and all payments must be up-to-date before services can be resumed. Failure to meet the agreement may lead to collections or withdrawal from the school. Any fees accrued due to the collection of funds will be the responsibility of the paying party.

If the student gets transferred or withdrawn before My Schoolhouse receives the quarterly funds, the paying party responsible must reimburse the school for tuition or fees not yet received.
